1) The International Experts Order (IEO)

You become a member of the Order, you are registered on the Roll of International Experts. This first module introduces you to the Order and gives you a general overview.

2<u>) UN</u>

Static approach, dynamic approach, the United Nations is the first of the international institutions to know for an international expert. We will particularly insist on the 2030 agenda and the 17 sustainable development goals to which we adhere. Our international expertise takes these objectives into account.

3) The international expert

We often have the question : what is an international expert ? So here is the answer, both in what it does and what it is.

4) The terms of reference

The TOR reflect the expert's mission. In this course, we will not only see what it is about, but we will also follow the recommendations of the UNDP (United Nations Development Program) to obtain the necessary skills to write ToRs on behalf of international institutions that call on the experts.

5) Sustainable development

All international expertise missions will have to take this into account. Many new assignments will be delivered to experts with the aim of sustainable development. The international expert must know what it is.

6) Expertise based on results

The research and development unit of OMEI is currently studying two major topics :

Remote expertise and results-driven expertise. She has already made a lot of progress on the latter. It can therefore transmit new skills to future international experts. As a member of the Order, you can participate in this cell.

7) The missions entrusted to the experts within the framework of the ecosystem of the order

The IEO is itself a source of missions, participations and activities. The research and development unit mentioned above is an example. As a member of the Order, you have access to the entire ecosystem: cells, commissions, corps, arbitration chamber, university of international experts, academy of international experts, institute of international experts.

8) IEO Online platform

It is a collaborative platform dedicated to expert members of the Order. Beyond missions that it offers, it makes it possible to carry out joint projects, to participate in monitoring international expertise, to respond to international calls for tenders. With the opening of access to the platform you benefit from a network of international experts.

9) World peace and international mediation

We plan, in 2022, to create a body of expert mediators. Mediation is a form of conflict resolution. This module gives you a 2eal example of international mediation.
